- ▶ **Mandatory public liability cover**
up to the indemnity limit of 336,566.78 euros established by law.
- ▶ **Legal defence and posting of bonds.**

Mandatory cover may be supplemented with a wide selection of optional cover:

- ▶ **Voluntary public liability cover** extending and complementing the mandatory public liability cover, with different limits available.
- ▶ **Claims for damage** caused by third parties to the insured boat or any of its occupants.
- ▶ **Damage to the boat:** partial damage, total loss or theft. Covering: Hull, engine, sails, masts, auxiliary craft, special fixtures and equipment, personal belongings and trailer. With the option of choosing general conditions in accordance with Spanish or Yacht Institute clauses.

The insured amounts must correspond to:

- ▶ **The purchase value as new**, if the boat is no more than two years old.
- ▶ **The actual market value**, if the boat is more than two years old, in accordance with an Assessment and Condition report prepared by a marine surveyor.
- ▶ **Wreckage removal.**
- ▶ **Salvage expenses.**
- ▶ **Pollution-related damage.**
- ▶ **Cover for coastal or high-seas regattas of an amateur and unsponsored nature.**
- ▶ **Claims for damages (including legal costs) and advances on indemnity payments:** limit of 2,500 euros up to 15,000 euros.
- ▶ **Personal accidents:** cover for loss of life or bodily injury to the occupants of the insured boat and/or water-skiers and/or skipper, while on board the boat and while embarking and/or disembarking. Covering:
 - Death.
 - Permanent disability.
 - Medical assistance (including medications).
 - Burial expenses.

With a choice of different indemnity limit options for the skipper as well as for passengers and water-skiers.
